Once sited skips **MUST NOT BE MOVED**. The skip is the full responsibility of the hirer and any damage caused where repairs are necessary will be recharged to the hirer. Skip hire is for 3 weeks from delivery date and will then be automatically raised as a collection. Extra hire must be requested at least 48 hours prior to end of hire date but is only available at the discretion of DRS (charges may apply). Please note that during busy periods there could be lengthy delays on skip collections, but we will endeavour to remove off hired skips at our earliest convenience so please bear with us. Once off hired the skip remains the responsibility of the hirer until collected. Cash customers please note - we hold on to your bank details until the skip is collected to cover any potential additional charges, if any, you will be notified of the amount and then it will be deducted from the card and then your bank details destroyed.

Skips should only be filled level with the sides and not heaped and greedy boards are not permitted. Dangerous or overloaded skips will not be collected until rectified. If a service is requested or the skip is off hired it is the responsibility of the hirer to ensure the skip is always made fully accessible for collection/service. Any overfilled skips, delays or wasted journeys where we are unable to deliver/collect/service the skip due to access issues or obstruction will be assessed and charged for accordingly.

Derwent Recycling Services Ltd will **NOT** be held responsible for any damage caused to private property, driveways or private land during delivery or collection should you request a skip be placed off road, this is at the owner's risk.
